**& WHY YOU NEED IT** 

While we can't map the future to predict the occurrence of an emergency, we can prepare the proper policies and procedures to limit any impact, but how do we do that?

First, we need to understand that each state and territory has their own Workplace Health and Safety Act. All employers have an obligation to provide a safe environment allowing workers to carry out their job without any risks to their personal health and safety.

## **Individual State's Workplace Health & Safety Acts**

The Workplace Health and Safety Acts don't necessarily provide an overview of the plans and processes to implement to safeguard the workplace. Individual states also follow respective' Health & Safety Act. Leaving a heavy burden on the owner of a business to come up with a plan.

# AS3745:2010 **TO THE RESCUE!**

Planning For Emergencies In Facilities

Australian Standard 3745:2010 was formed to enhance the safety of people in facilities. AS3745:2010 Planning For Emergencies in Facilities and AS 4083-2010 Planning For Emergencies in Health Care Facilities layout a detailed framework that provides best practice for dealing with emergencies within a facility. The standards act as a guide to ensure all states meet the requirements of their respective' Health and Safety Act.

# What are the key aspects of AS 3745-2010?

You must ensure an Emergency Plan is prepared for the workplace which includes:

#### **Emergency Planning Committee (EPC)**

Emergency Planning Committee, which must comprise at least two people, who are representatives of stakeholders in your facility. One of these members should be management and at least one member of the EPC shall be competent. In most facilities, the EPC is made up of:

- » Senior management
- » Tenants or Staff
- » Chief Warden
- » Specialist facility personnel e.g. maintenance engineer
- » Occupant with a disability, where possible

#### **Emergency Control Organisation (ECO)**

The ECO implement the emergency procedures in a building, including the evacuation of the occupants. It's a structured team of people employed within a building who take command on the declaration of an emergency.

The number of ECO members is dependent on

- » Size of the facility, floor or area » Number of occupants and visitors
- » Installed occupant warning equipment
- » Fire engineered and life safety features of the facility.



The Emergency Plan must include:

- » Emergency procedures
- » Testing of the emergency procedures, including the frequency » Information, training and instruction to relevant staff members
- in relation to implementing the emergency procedures.



### **Required Frequency of Training**

Training and validation must be conducted at specified intervals:

- » ECO members every 6 months » Other Staff Members - every 12 months
- » Evacuation Exercise every 12 months
